Term & Conditions linked to online sale

Article 1: Preamble

These conditions of sale are concluded, on the one hand, by the company Impacta sprl, whose registered office is at Clos du Champ d'Abeiche 20, 1420 Braine L'Alleud, registered with the Crossroads Bank of Enterprises under the number BE 0821.197.050, hereinafter referred to as "the seller" and, on the other hand, by any natural or legal person wishing to make a purchase via the website of the seller, hereinafter referred to as "the buyer".

Article 2: Purpose

The present conditions of sale aim to define the contractual relations between the salesman buyer and the conditions applicable to any purchase made through the website of the seller, whether the buyer is a professional or a consumer. The acquisition of a good or a service through this site implies an acceptance without reserved by the buyer of these conditions of sale. These conditions of sale will prevail over all other general or special conditions not expressly approved by the seller. The seller reserves the right to modify his conditions of sale at any time. In this In this case, the conditions applicable will be those in force on the date of the order by the buyer.

Article 3: Characteristics of goods and services offered

The products offered are those listed in the catalog published on the website of the seller. Each product is accompanied by a description as far as possible drawn up by the supplier. The pictures in the catalog are as faithful as possible but cannot guarantee perfect similarity with the product offered, especially with regard to colors. These products are offered within the limits of available stocks. If, despite his efforts, all or part of the items are unavailable, the seller informs the buyer by email as soon as possible and offers him the opportunity to choose between wait or cancel without charge the order of unavailable items. Available items will be delivered normally.

Article 4: Prices

The prices of products and services displayed on the Furniture Platform are indicated in euros VAT excluded. At the quoted prices, excluding VAT, a transaction cost and VAT are added at end of the booking process. The seller reserves the right to change prices at any time. However, the prices applicable to the order are those in effect at the time of confirmation thereof. The prices quoted do not include the cost of order processing, transportation and delivery provided that they take place in the geographical areas specified below.

Article 5: Geographical Zone

The online sale of products and services presented on the seller's website is reserved for Buyers who reside in Belgium.

Article 6: Orders

The buyer who wants to buy a product must:

- fill in the identification form on which he will indicate all the coordinates requested;
- fill out the online order form giving all the references of the products or selected services;
- validate the order after having checked it;
- make the payment in the prescribed conditions;
- confirm the order and payment.

The confirmation of the order implies acceptance of these terms of sale, the recognition of having perfect knowledge of it and the renunciation to avail oneself of its own purchase conditions or other conditions. All data provided and the recorded confirmation will be worth proof of the transaction.

Confirmation will be worth signing and acceptance of transactions. The seller will communicate by e-mail confirmation of the order recorded.

Article 7: Terms of payment

Payment is by credit card or PayPal. The ordered items remain our exclusive property until full payment of the order by the buyer.

Article 8: Deliveries

The goods are removed by the buyer at the delivery address specified by the buyer. From this moment, the buyer assumes the risks alone. Delivery times are only indicative; if they exceed thirty days from the order, the contract of sale may be terminated and the buyer refunded.

Article 9: Guarantee

With regard to consumers, the seller guarantees the products he sells and the services he provides in accordance with the law of 1 September 2004 on the protection of consumers in case of sale of consumer goods (articles 1649 bis to 1649 octies of the Civil Code).

Article 10: Right of withdrawal

In case of nonconformity of a product sold found in the day of collection of the goods, the consumer must notify the seller as soon as possible in a precise manner by electronic mail. This warranty only covers existing defects of conformity at the time of delivery of the goods. The invoice or delivery note serves as a guarantee and must be retained by the Consumer.

Article 11: Liability

The seller, in the process of selling online, is bound only by an obligation of means; he cannot be held liable for damage resulting from the use of the network Internet such as data loss, intrusion, virus, service disruption, or other problems involuntary.
